

**Privacy Notice**  
**Durham County Council**  
**Children and Young Peoples Services**  
**Children's Social Care**

This Privacy Notice explains how we use and share information. We will review and update this privacy notice to reflect changes in our services and feedback from service users, as well as to comply with changes in the law.

### **Who we are and what we do**

Durham County Council have statutory responsibility for ensuring the safety and wellbeing of children and young people.

For the purposes of Data Protection, Durham County Council is the Data Controller

### **What type of personal information do we collect and how do we collect it?**

In order to provide you with high quality and safe services which are relevant to your needs, the Council will collect and hold information about you. This may include:

- Basic details such as your name, address, date of birth, NHS number
- Parents/carers, family members - name, address, contact details
- Housing records
- Education records
- Police reports
- Information from the Youth Offending Service
- Relevant information about your background and circumstances

We also collect the following special category data:

- Gender
- Ethnicity
- Religion
- Medical information
- information from other professionals who may be involved with you e.g. CAMHS, substance misuse

We collect information about you in the following ways:

- Face to face
- By secure email
- By post
- By telephone
- From other professionals

## **What is our lawful basis to obtain and use your personal information?**

To enable us to provide services to you it is necessary for us to use your personal information to help assess your needs and identify the most appropriate services available. To do so we will use the following legal basis for sharing your information:

- Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

For special category data which is more sensitive information, we rely on the following:

- Health and Social Care - we use it for the provision of health or social care or treatment or the management of health or social care systems and services

## **What is your personal information used for?**

Your records will be used to enable us to give you the best possible care and support. Records will be held in electronic and paper format and they will be used by staff involved in your care for your care, protection and support.

Your information will also be used to provide assurance to the Council about the quality of services provided.

## **Use of your NHS Number in Children and Young Peoples Services**

If you are receiving support from Children and Young Peoples Services (CYPS) then the NHS may share your NHS number with CYPS.

This is so that the NHS and Children and CYPS are using the same number to identify you whilst providing your care. By using the same number the NHS and CYPS can work together more closely to provide your care and support services.

We will use this Number when sharing information with health colleagues including GP's, hospitals, community matrons, district nurses and social care practitioners.

## **Will your personal information be shared?**

Sharing information helps us to provide you with the best care and support possible.

We will only share relevant information about you with other services when they are involved in your care and support or where there is a legal basis for doing so. There are a range of professionals who may be involved in providing services to you and where appropriate will be provided with relevant information about you. Agencies we may need to share information with include the following:

- NHS Organisations
- Education Professionals
- Care Providers, such as Foster Carers, Children's Homes
- Housing agencies
- Child and adolescent mental health services(CAHMS)
- Substance Misuse Service Providers
- Youth Offending Service,
- Police
- Courts

There are other times not linked to your care and support where we may need to share your information. These include:

- Where there is a serious risk of harm to you or to others
- Where there are concerns for the welfare of a child
- For the Prevention or detection of crime
- Where a court order requires us to share information about you

## **How do we keep your information secure?**

The security of your personal information is important to us. The records we keep about you are secure and are confidential within the Council. The Council have a range of procedures, policies and systems to ensure that access to your records are controlled appropriately.

Anyone who receives information from us is also under a legal duty to only use the information for the purposes agreed and keep the information secure and confidential.

## **How long will we keep your personal information?**

After we deliver a service to you, we have to keep your information as a business record of what was delivered. The type of service you receive will determine how long we have to keep your information.

Currently children's records cannot be destroyed due to independent enquiries in England and Scotland into child abuse and information will not be destroyed until 6 years after the end of the enquiries or in accordance with our normal retention schedule (whichever is later).

Our [corporate retention guidelines](#) show how long we keep information for different services. Your records will be retained in accordance with Durham County Councils records retention schedule as follows:

Some information e.g. registers, may be passed to the County Archives; this information will be held securely and access will be limited to those who have a legal right to access these records in accordance with data protection law.

## **Is your personal information processed outside of the European Economic Community (EEC)?**

We do not process your personal data outside of the EEC

## **Marketing**

At no time will your information be used or passed to others for marketing or sales purposes, or for any commercial use without your express consent.

## **What are your information rights?**

Your Information Rights are set out in the law. Subject to some legal exceptions, you have the right to:

- have any inaccuracies corrected;
- have your personal data erased;
- place a restriction on our processing of your data;
- object to processing; and
- to request your data to be ported (data portability).
