The meeting was also attended by 9 observers.

## 1. Introductions, Apologies and Declarations of Interest

The Chair welcomed Ian Coull as a new Board member. Ian works for South Durham Enterprise Agency and will be our Business Representative.

Everyone was welcomed everyone to the meeting and introductions were made around the table. Apologies were given as received. Observers in attendance were also welcomed and given the opportunity to introduce themselves.

No conflicts of interest were declared.

The Chair stated that the agenda would be adjusted slightly to allow presentations to be given first.

## 2. Presentations

### a) *'A Matter of Honour', Tim Bird*

The presentation was given to encourage more nominations from the area for UK honours and awards. The North-East is currently under-represented in these areas. These awards recognise when people have made a difference and have gone above and beyond. A copy of the presentation is held on file in the WAP office.

The Chair thanked Tim for his presentation.

### b) *Youth Service Review – Julie Scurfield*

A review of the Youth Service Provision in County Durham is currently under consultation with a move towards a targeted youth service being proposed. A 12 week public consultation runs from 1<sup>st</sup> February to 27<sup>th</sup> April and a final decision by cabinet is expected in autumn 2016. The Chair thanked Julie for her presentation and opened the room for questions.

- PS asked where the targeted youth services would be provided. Julie advised that the targeted model is designed to benefit not only those who live in deprived areas but also those who do have additional needs. The new model is taking the service to the people.
- Beryl Brown asked how this would affect Stanhope Community Centre. Julie confirmed that the evening youth clubs will cease allowing for the release of the youth worker to work in a more targeted way in the locality. She confirmed that a decision on the location of a base would be made further into the process but would expect some form of base to be in Weardale.
- Julie also confirmed that it was anticipated that the Duke of Edinburgh provision would continue but in a more targeted way. She also advised that the Duke of Edinburgh office is looking to work more closely with schools in order to provide this service.

- PS queried the practicalities of implementation. Julie advised that the withdrawal of services is anticipated 3 months after the decision by cabinet. It is expected that the new service will be in place early 2017.
- CP expressed concern with regard to targeting in this area as much of the deprivation is hidden. Julie advised that they are working with young people to ensure that they know how to access the youth workers who will remain.
- BT asked how Weardale compares to the rest of the county and also questioned the genuineness of the consultation. Julie reiterated that the bottom line is the loss of £1 million to the budget and that changes need to be implemented.
- SW asked whether last year's entire budget had been spent and whether the department was on track to spend its entire budget this year. Julie confirmed that this is the case.

All Board members were encouraged to participate in the consultation process.

**c) Urgent Care Consultation – David Taylor-Gooby**

DDES CCG has a contract with Durham Hospital Trust to provide Urgent Care. Urgent Care centres are currently located in Bishop Auckland, Peterlee, Easington and Seaham. The contract is due to be renewed and GPs would rather the contract was given to them to run Urgent Care. DT-G advised that this is not a cost-cutting measure but rather a more efficient use of what is already there – trying to avoid duplication and non-usage of services.

DT-G advised that there will be meetings held in Bishop Auckland Rugby Club and Wolsingham Sports Hall and suggested that if the Board felt that a meeting in Stanhope would be beneficial then to write to the NHS.

- **2015/16 Task Group Updates**

**1. Employment, Jobs and Tourism**

PS provided an update to Board members

- a) **UTASS Training** – UTASS have received the money and the uptake on courses has been good.
- b) **Killhope Refurbishment** – Seat will be installed in next few days.

## 2. Support and Activities for Children and Young People

CP provided an update to Board members

- a) **Sports Activators** – 2 new apprentices are now in post and doing well. They have gained lifeguard and Walk4Life instructor / leader qualifications.
- b) **Stanhope Barrington Nursery Provision** – This project is now being led by Stanhope Barrington Primary School – all other details remain the same.

**RECOMMENDATION: The Board AGREED to fund this project to the sum of £15,000.**

## 3. Health and Wellbeing

DT-G provided an update to Board members

- a) **Community Wellness Coordinator** – The Community Wellness Coordinator (CWC) will work with local GP Federation to try and reach those who may have difficulty accessing services and help.

**RECOMMENDATION: The Board AGREED to fund this project to the sum of £33,333**

YP requested that once the CWC is in post that they come and speak to DCA to ensure that there is no confusion between this project and the Wellbeing for Life programme.

## 4. Small Grants Fund

Stanhope Silver Band – *Replace heating system*  
InterOpera – *Opera workshops for young people. Note: the group will give a performance at 2:30pm on Friday 22<sup>nd</sup> April at Upper Weardale Town Hall – all welcome.*

Wolsingham School – *Multi Use Games Area (Not Small Grants) – AS advised the Board that this is already a well-used facility and expressed her gratitude to the WAP for their support and funding which has provided this community resource.*

### **Support to Groups in Weardale**

The Appraisal panel have put forward a request to the Board to ring-fence funding in order for the Small Grants Fund to continue.

**RECOMMENDATION: The Board AGREED to ring-fence £25,000 for the Small Grants Fund.**

## 8. Countywide Partner Issues

### ***Rural Crime Issues – Ron Hogg, Durham Police and Crime Commissioner***

- Durham Police Force has been declared as outstanding
- Figures for recorded crime are increasing due to a change in the practice of recording procedures for harassment.
- Working with other PCCs to develop effective Crime Prevention strategies against Cyber Crime and seek to jointly investigate crimes where possible.
- ASB continues to fall but pockets remains. Members of the public are encouraged to call in any instances of ASB to ensure accurate recording.
- Anyone unsatisfied with police response encouraged to contact PCC office.
- Police budget has been top-sliced for counter-terrorism measures. The precept has been raised to bring in additional funding. However, imminent pay rises and additional costs will result in the losing of another 50 staff.
- Commitment to Neighbourhood policing remains. PCSOs to increase to 170.

- 60%+ of the community think that speeding is a problem. Average speed cameras reduce average speed and lessen the number of accidents.
- 'Keep in the Know' officially launched – this is not a means of reporting crime. Further information at <https://www.keepintheknow.co.uk/>

The Chair thanked Ron for his presentation and opened the room for questions.

- DC advised of a lack of response to a report to serious damage to machinery at Bollihope. Ron asked DC to pass on the information to his office for him to take forward.
- MH stated that speeding is a problem in Edmundbyers describing it as a 'rat-run'.
- PS asked how special constables are recruited in this community. Ron advised he will check whether this is in the Weardale Gazette.
- BT suggested that speeding is not a problem in the villages but rather on the roads in between. There are problems with motorcyclists and certain locals. Ron advised that cameras can be used on open roads – this would be a matter for consultation with the local community.
