

I STEPHEN DOWSON DO SOLEMNLY AND SINCERELY DECLARE AS FOLLOWS:


- 1. I am and have been since 25th April 1994 the owner within the meaning of the above section of the Highways Act 1980 of the land adjacent to Elm Park House to the North side of Elm Park Road in the region of Shotley Bridge Co. Durham more particularly delineated on the map accompanying this statement and thereon edged red.
- 2. On the 9th day of July 2013 I deposited with Durham County Council being the appropriate Council a statement accompanied by a map delineating my property by red edging which stated that the ways coloured purple on the said map and on the map accompanying this declaration had been dedicated as footpaths and that no other ways over the land had been dedicated as highways.
