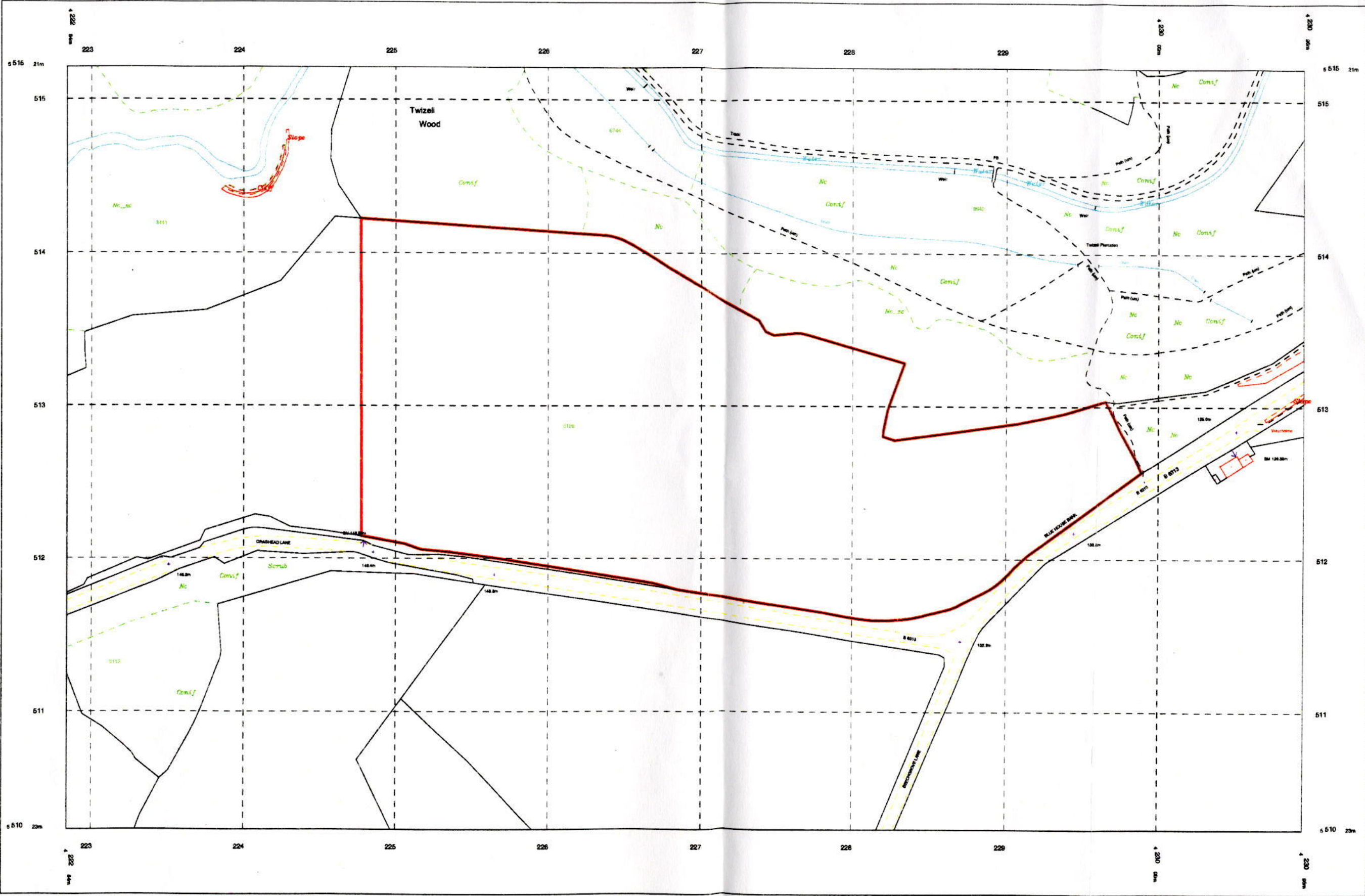

conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

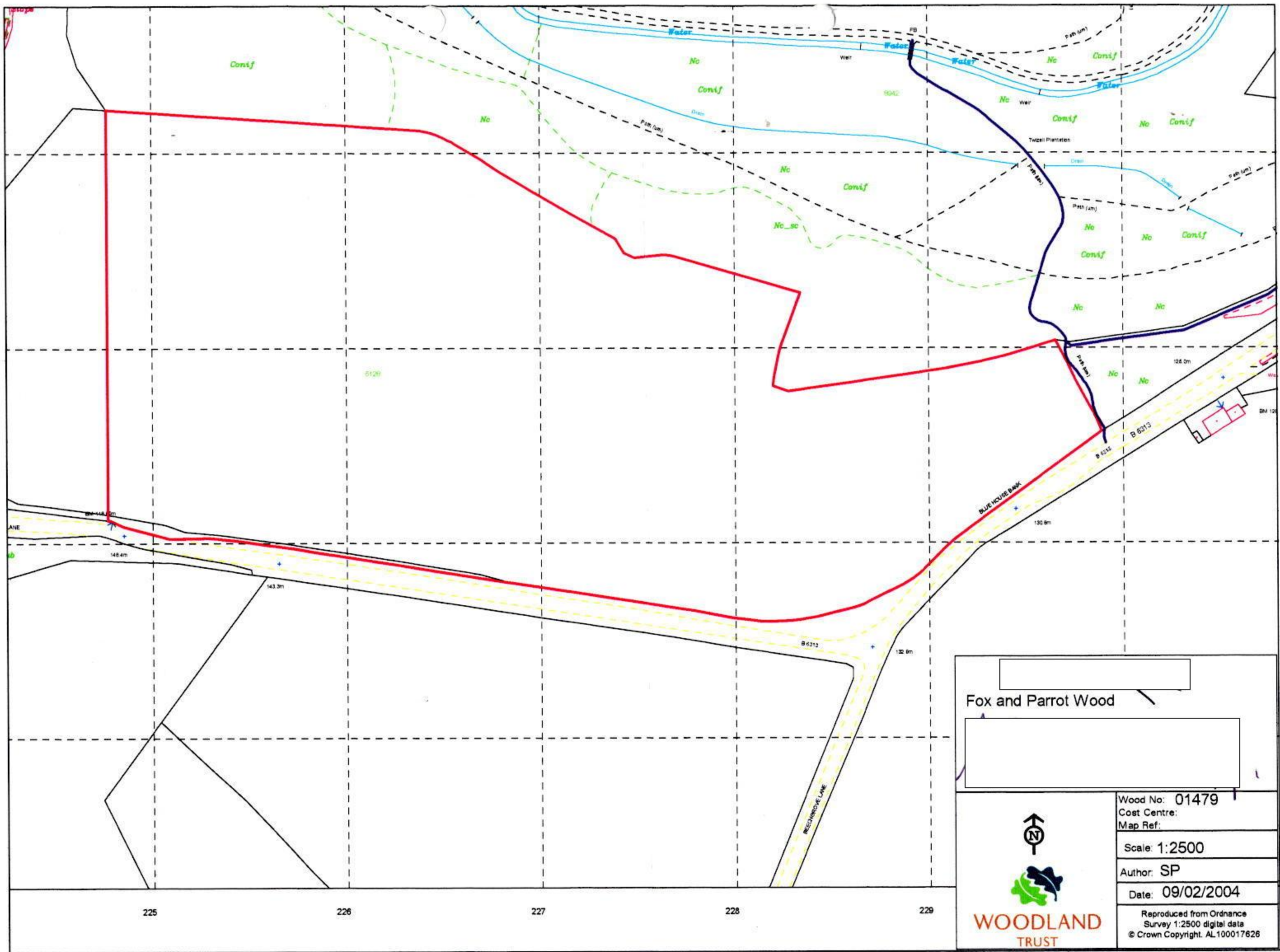

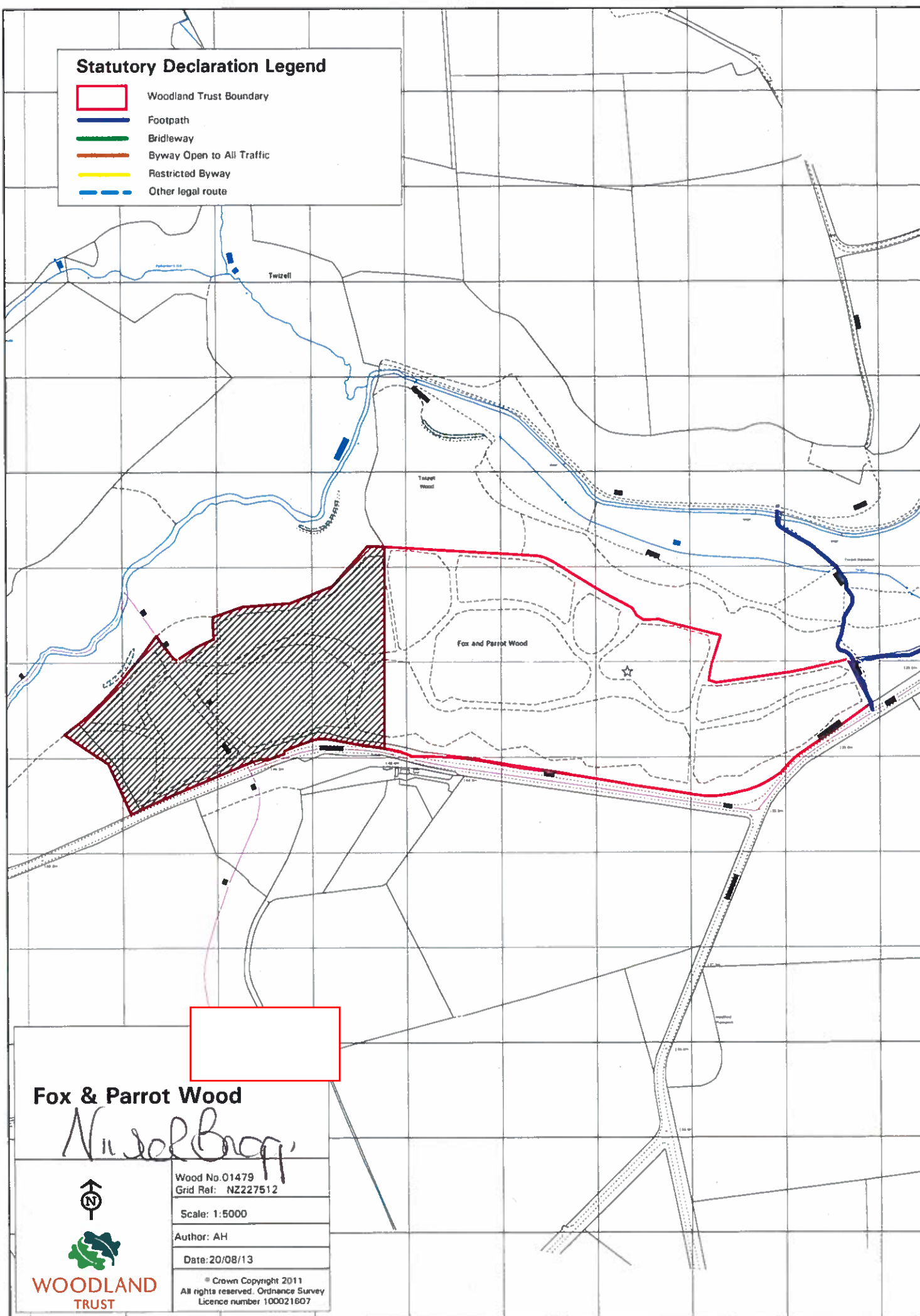
